Price: The price for any product (hereinafter "Product") or service shall be the price stated in the Bio-Rad Laboratories, Inc. (hereinafter "Bio-Rad") quotation. Bio-Rad's quotations are valid for ninety (90) days unless otherwise stated in the quotation. Prices stated are exclusive of all taxes, fees, licenses, duties or levies and, unless otherwise stated in the quotation, transportation charges, freight and insurance. All pricing and special offers are subject to approval by Bio-Rad's National Sales Office and are not binding until this review is complete and approval has been given. Discounts only apply to the Products and Services that are ordered under the same purchase order number or placed at one time. Educational pricing is contingent upon receipt by Bio-Rad of a signed educational voucher submitted with the purchase order. The attached quotation supersedes/cancels all previous quotations on the Products and Services stated in the quotation number must be referenced on your purchase order.

Shipping and Handling: : Unless otherwise requested, stocked items will ship within 48 hours on a carrier selected by Bio-Rad Back-Ordered items will ship as available. Unless specifically quoted, shipping and handling charges will be prepaid and added to the invoice (PPD & Add). Shipping for this quote is FOB Destination.

Unless otherwise stated, a one time freight charge as described below will apply:

- \$30.00 freight charge for orders with a total value of \$0 to \$1,000.00
- 3% of the total value of the order for orders with a total value from 1,001.00 to 20,000.00
- a maximum charge of \$600 for orders over \$20,000

Warranty: All products sold by Bio-Rad Laboratories (Canada) Ltd. are guaranteed to meet the specification listed in our catalogue. Should a Bio-Rad branded product fail to meet specifications during its warranty period, it shall be repaired or replaced at Bio-Rad's discretion.

In general, all products sold by Bio-Rad Laboratories (Canada) Ltd. are warranted for a period of 1 year, any exceptions to this period of coverage will be noted on the quotation.

Instrument warranties do not include consumable parts such as o-rings, batteries, lamps, lasers and platinum wire. Repairs required as a result of misuse, improper use, instrument modification or unauthorized repair attempts during the warranty period will not be covered by the original or extended warranties and will be billed at current rates for parts, labour and travel. Chemicals and other consumables are warranted through their expiration date as indicated or for 1 year if there is no expiration date. Non Bio-Rad branded products such as computer seripherals, are covered by the original equipment manufacturer's warranty. Warranties are not transferable from the original purchaser and warranty coverage may be void if the product is moved outside of Canada. Repairs performed on instruments that are no longer covered by the original or extended warranty carry a 90 day warranty for labour and on the parts replaced.

The warranty will commence the day after a product is shipped unless installation/training is quoted and/or purchased with an instrument. If installation/training has been explicitly purchased/included (catalogue #'s ending in "T"), the instrument warranty will commence the day the installation and training was completed or ninety (90) days after the date of shipment (whichever occurs first). The above warranty extends only to the original buyer and can not be transferred to a subsequent owner.

Product warranty, regardless of duration, is valid only within Canada and covers defects in material and workmanship.
